



CODE OF CONDUCT/ COMMUNITY AGREEMENTS

Our shared commitment to kindness, generosity, and mutual respect creates the foundation for an incredible experience together. By embracing these guidelines, we ensure everyone feels safe, respected, and included. Violations of these agreements are subject to security review and possible disembarkation. Depending on the violation, arrest by local authorities may be warranted. Guests who are disembarked due to a code violation are not entitled to receive a refund for any lost cruise days.

RESPECT - In general, all guests are expected to respect any directions given by a ship's officer or crew member. This is to ensure your safety and the safety of all VACAYA guests.

ILLEGAL DRUGS - There is a zero-tolerance policy regarding illegal substances. Anyone caught using or selling will be disembarked and will be subject to the laws of the port of disembarkation. Please note that most embarkation ports have drug-sniffing dogs patrolling the terminal and examining all checked bags.

INTOXICATION - Our standard policies are in effect for this charter. Should a guest appear overly intoxicated, beverage service will be stopped, and they will be escorted to their stateroom to rest and recover.

SEXUAL ACTIVITY - VACAYA and each of our big-ship cruise line partners and most resort partners have provided a designated space for public sexual activity. The Red Light District is the only space on a VACAYA charter/resort takeover where sex in public is appropriate. Sex in all other public spaces is forbidden. Please use your stateroom for private connections.

NUDITY - Public nudity is only permitted within The Red Light District or when an event specifically states that nudity is allowed. In all other areas, clothing must be worn. The one general exception to this is when we offer a Clothing Optional Sundeck (COS). If one is offered, you are allowed to be without clothes in this space at the times indicated. On big-ship cruises, the COS is always closed while the ship is in port.

GENERAL SOLICITATION - Guests are not permitted to pay nor accept payment to engage in any form of entertainment or sexual activity or to offer payment to ship staff.

RESPECT FOR CREW MEMBERS - A ship's crew members are strictly forbidden from engaging in sexual activity with guests. So, please respect the crew members who are there to serve you and do not cross the line of inappropriateness with them at any time. Violating this rule will not only lead to the crew member's immediate dismissal, but you will also be disembarked in the next port of call.

SMOKING - Smoking is ONLY permitted in the designated smoking area. Cigars and tobacco pipes are generally permitted in the smoking areas, but if they're forbidden, we'll communicate that clearly. Smoking of any kind, including electronic cigarettes, is not permitted in guest staterooms or on verandas. Any in-stateroom violations will result in a \$250 per day cleaning fee being charged to your onboard/resort account. Smoking of water-pipes, glass-pipes, or other smoking devices is not permitted onboard. With our cruises, smoking is not permitted on open decks during fuel bunkering operations in port.

Accountability and Generosity

We all share responsibility for co-creating the extraordinary environment VACAYA offers. By following these guidelines with kindness and care, we contribute to a conscious, respectful, and joyous experience for everyone. Thank you for bringing your best self to this journey.

RED LIGHT DISTRICT COMMUNITY AGREEMENTS

The Red Light District (RLD) is a shared space designed to foster exploration, empowerment, and connection within a sex-positive, inclusive, and kink-aware community (the "K" in LGBTQIAPK). Participation here is about co-creating a culture of respect, safety, and mutual care. Together, we lift each other up with kindness, generosity, and an intentional commitment to collective well-being.

Our Shared Commitment

1. Creating a Supportive and Respectful Space

- We come to this space with maturity, independence, and resilience, ready to contribute to a community where everyone feels welcome and empowered.
- We take responsibility for our emotions and practice self-regulation. When challenges arise, we commit to responding with patience, self-awareness, and curiosity.

2. Engaging with Care and Consent

- Respecting one another is at the heart of this community. We value open communication and mutual respect, particularly when navigating topics such as consent, gender identity, body inclusivity, and STI transparency.
- We align with RACK (Risk-Aware Consensual Kink) by:
 - Being informed about the risks of our activities.
 - Ensuring all interactions are based on enthusiastic, informed, and ongoing consent.
 - Prioritizing safety and considering the impact of our actions on ourselves and others.

3. Co-Creating Readiness

- If we feel unprepared to navigate the complexities of this environment, we agree to honor our personal growth journey and return to the RLD on a future VACAYA trip, when ready to participate fully and positively.

Assumption of Risks:

1. I understand and accept that engaging in a sex progressive space and implied activities involving inherent risks, include but are not limited to the risk of physical injury, illness, or psychological impacts including mis-gendering, body exclusion, and rejection due to personal preference. By participating, I acknowledge these risks and commit to engaging responsibly.
2. I acknowledge that the consumption of alcohol prior to or during the experience may impair my judgment and coordination, and I agree to drink responsibly.
3. I acknowledge that the consumption of illicit drugs is prohibited and violates both the VACAYA and cruise line's Code of Conduct.
4. By participating in Red Light District activities, I acknowledge there are inherent risks. By entering the RLD, I am willingly engaging in them at my own risk. I release VACAYA LLC, and the cruise line/resort, their owners, employees, agents, and affiliates from any and all legal liability, claims, actions, or demands that may arise as a result of my participation in these activities or any related services.

Personal Responsibility in Community

I agree to:

- Report behaviors that violate these agreements to the RLD monitors promptly.
- Take responsibility for my belongings, understanding that VACAYA and its partners are not liable for loss or theft.
- Exercise judgment and agency in deciding how and when to participate, recognizing I am free to opt out of any activity at any time.

Consent Practices Rooted in Kindness and Generosity

- As a community, we prioritize the following consent practices:
 - Communicating clearly about our boundaries, desires, and limits.
 - Honoring each other's autonomy and right to revoke consent at any time.
 - Being generous with kindness and understanding, recognizing that mistakes may happen, but accountability and repair are essential.
 - Approaching interactions with mutual respect, ensuring no one feels diminished.

Medical Disclosure

By entering the RLD, I certify I am in good physical and mental health and do not have any medical conditions or limitations that would prevent me from safely participating in RLD activities.

Emergency Medical Treatment

By entering the RLD, I consent to receive medical treatment deemed necessary by authorized personnel in the event of a medical emergency, and to be financially responsible for the costs associated with that care.

By participating in the Red Light District, I agree to:

- Take full responsibility for my own experiences, while holding space for others to do the same.
- Recognize that this is an experiential space I engage with voluntarily, mindfully, and with the understanding that my choices impact myself and the community.

Together, through kindness, generosity, and shared accountability, we co-create an environment where exploration and connection can flourish in respect and joy.
